An Update from the President

The academic year now well underway has been, and promises to be, an exciting one for the DSA. Dante Studies now makes a habit of publishing on schedule; we enjoyed a wonderful lecture from Rachel Jacoff in May and look forward to another from Jeffrey Schnapp in January; the prize committee received such strong and varied essays that they felt compelled to add an "Honorable Mention"; and we have now launched a listsery to enhance communication both to and among the members. The Society's Council. moreover, continues its work in preparing a restructured, technologically advanced and sustainable future for the Society.

Prompted by reading your responses to our 2011 Survey of the Membership, the Council has made progress on the revision of our half-century old by-laws. In your comments most of you expressed appreciable satisfaction with the Society and its operations, but many of you also encouraged us to expand our geographic reach. Several by-law articles—ones that were once, but no longer are, required by Commonwealth law—restricted specific operations and events to Massachusetts. Revision was clearly necessary, and we set about it remaining at once respectful of our traditions of governance and committed to meeting the needs of a twenty-first-century scholarly society.

We have now reviewed the draft bylaws prepared to our specifications by our team of (for the most part) pro bono lawyers. After final revisions, we plan on circulating the document to you by mid-February. A comment period will follow in which questions and/or objections can be raised, answered or incorporated. Our listsery will be critical to this process, though we will be careful to mail to those without email addresses. A vote is projected for our May 18 meeting.

The coming year will thus be a critical one for the Dante Society, and our progress will depend upon your participation. The Council joins me in thanking you in advance for your thoughtful attention.

Annual Meeting, May 2012

The Dante Society of America's 130th Annual Meeting took place on May 19, 2012 at the Longfellow House –

Washington's Headquarters National Historic Site in Cambridge, Massachusetts. At 11 a.m., President Vickers called the meeting to order and introduced Park Ranger Garrett Cloer who welcomed the DSA members to the estate.

The Minutes of the 129th Annual Meeting were read and approved. The Acting Secretary-Treasurer reported on the good health of the Society's finances, highlighting recent changes voted by the Council both in financial organization (the division of our longstanding Merrill Lynch account into operating and investment sub-accounts) budgeting (the introduction of a formal budget approval process). Audit Committee Chair Richard Lansing reported an unproblematic review of fiscal vear 2011. The Audit Committee's and Treasurer's reports were approved. Following reports from the Nominating and Prize Committees, the President thanked retiring Councilor Victoria Kirkham for her service. She also outlined the timetable for by-law revision (see above) and administrative reorganization before opening the floor for discussion.

President Vickers then introduced Rachel Jacoff (Margaret and LeRoy Carlson Professor of Comparative Literature, Emerita, Wellesley College), who presented a wonderfully illustrated and engaging lecture on "Dante and Rome." Following a lively discussion the group adjourned to the House's historic garden in full bloom for refreshments (see Rachel below) and conversation.

Spring Election Results

Last May the DSA membership elected Albert Russell Ascoli and Arielle Saiber to the Council for 2012-15. Nancy Vickers was elected as Acting Secretary-Treasurer for 2012-13. Later the Council voted to appoint Vickers to a second, and final, three-year term as President (2012-15). They also elected Ascoli as Vice President for a term of one year.

Essay Prize Winners for 2012

The Dante Prize for the best undergraduate essay was awarded to William Porter (The State University of New York, Geneseo) for an essay on "The Clockwork of Dante's Cosmos: Some Uses of Time in *Paradiso*."

The Charles Hall Grandgent Award for the best essay by a graduate student went to Leah Schwebel of the University of Connecticut for her essay "'Simile Lordura,' Altra Bolgia: Authorial Conflation in *Inferno* XXVI." The Committee also awarded an "Honorable Mention" to Katie Guida of The Pennsylvania State University for her essay "Fellini and Dante: Life and Death in *La dolce vita*."

Prize Committee members Victoria Kirkham (Chair), Dennis Looney and Vittorio Montemaggi judged the essays. The Committee reads essays as "blind submissions" and awards \$500 for the best undergraduate essay and \$750 for the best graduate essay. The deadline for submissions for the 2013 competitions is June 30th. Further details can be found on the Society's website under "Prizes."
